Nominating Committee meeting results

A Nominating Committee consisting of Roger Bearce, Wagner Harmon, Mike Fisher, Eugene Fisher, Don Diede and Brian Ligon met at Lower Yellowstone Rural Electric Association's office March 17. The purpose of the meeting was to submit candidates for the election of directors for District 5, 6 and 7, which will be held during the June 4 annual meeting.

The committee selected Calvin Vannett, Dennis Nelson and Marty Bearce for District 5, Greg Rauschendorfer for District 6 and Allen Thiessen for District 7. Candidates may also be nominated by petition or from the floor at the June 4 annual meeting.

DISTRICT 5 **Calvin Vannett**

Calvin Vannett spent his early years on the Larson family farm in Buford/Trenton Valley. He joined the National Guard during his senior year in high school, leaving for basic training upon graduation. He later attended North Dakota State College of Science, majoring in auto mechanics. During this experience, he was elected to the Student Cabinet, serving as a representative for the Trade & Technical Division. In addition, he was active in several campus clubs. Calvin later attended Lutheran Bible Institute of Seattle where he met his wife, Barbara-Anne. They have five sons.

Calvin joined the U.S. Army in 1987 and the family moved to Germany, where he served as a company training NCO. In 1990, he deployed to Operation Desert Shield and Desert Storm, serving as a chaplain's assistant, ammunition inventory assistant and bivouac site maintenance.

Upon discharge from the Army, he returned to North Dakota, living in Fargo. There, Calvin worked for various trucking companies before beginning his own over-the-road trucking enterprise. Calvin enjoys participating in the church community and was instrumental in starting a men's ministry at his church in Fargo.

During 2011, Calvin decided to return to his roots in "the valley," moving his family onto the family farmstead. Since returning to this area, he expanded his carpentry skills, forming Prairie Custom Contracting. He also works for Fort Worth Pipe (a division of Savage Services), a logistics company.

He graduated from Lambert High School and attended Montana State University. In 1980, he returned to manage the family operation where he presently resides with his wife, Donna. SRS dispatch here to help

Lower Yellowstone Rural Electric Association (LYREA) continues to strive to serve its members in the best way possible. In doing this, LYREA has changed the after-hours dispatch procedure and is now currently using Basin Electric Power Cooperative's Security and Response Services (SRS).

There are many reasons LYREA has altered the dispatch system that has been in place for many years. One main reason is better response during widespread outages.

When an after-hours outage occurs that affects multiple consumers, the consumers frequently get pushed to voicemail, do to the LYREA dispatcher being on the phone with other consumers. Often, one of the callers has pertinent information that can assist the line crews in finding the problem area and getting the power restored quicker.

The SRS system includes many incoming lines. Callers may also choose the automated system, but

if you would like to speak to a dispatcher, simply press 0.

Another vital reason the SRS dispatch is key is for safety issues. The SRS dispatchers have the capability to monitor our line crew's movements the entire time they are on a job.

SRS will answer calls after-hours, holidays and weekends. Please have your meter number available for the dispatchers when you call for an outage. During business hours, you will still reach the local office. ■



Savage Substation construction

In the early 1940s, when the original Savage Substation was built, life got a bit easier for the rural residents of Savage. Although the original substation has served its purpose for the past 70-plus years, it was time to upgrade the substation.

The new Savage Substation is unique among all of the other Lower Yellowstone Rural Electric Association (LYREA) substations. A pad-mount substation was installed rather than LYREA's traditional open-bus substation. The main reason LYREA chose the pad-mount substation over the open-bus substation is that the

pad-mount substation takes less space, and space was limited when the initial planning began for the substation.

With the new growth and added load in this area, a new substation was needed to ensure LYREA is able to provide reliable service to its consumers. During the 2012 and 2013 irrigation season, the Savage Substation was at its peak capacity. The 2,000-KVA transformer was replaced with a 5,000-KVA transformer to ensure this substation has the capacity needed to serve the members in this area. (Meter 21533) ■
